



County 40 Years Lottery Draw Terms & Conditions

- 1. By entering this prize draw, an entrant is indicating his/her agreement to be bound by these terms and conditions.
- 2. The promoter is: County Insurance Services Ltd whose registered office is at Glyme Court, Langford Lane, Kidlington, Oxford, OX5 1LQ.
- County Insurance Services Ltd 40 year lottery draw (hereby referred to solely as 'Prize draw') will run from March 1st, 2024 until 31st December, 2024. Entries received after this date will not be valid.

Appendix 1 – Thresholds

Business and Farm – Income Thresholds:

- Upto £1k income on a policy 1 ticket
- £1,001 to £2,500 income on a policy 2 tickets
- £2,501 plus 3 tickets

Personal – Income thresholds

- £100 to £150 income 1 ticket
- £151 to £300 income 2 tickets
- £301 plus 3 tickets

Schemes (Heritage & County) - income thresholds

- Upto £250 income 1 ticket
- £251-£400 2 tickets
- £400 plus 3 tickets
