



## <u>County 40 Years Referral Campaign</u> <u>Terms & Conditions</u>

- 1. By entering this Campaign, an entrant is indicating his/her agreement to be bound by these terms and conditions.
- 2. The promoter is: County Insurance Services Ltd whose registered office is at Glyme Court, Langford Lane, Kidlington, Oxford, OX5 1LQ.
